

1 **In my remembered country: what poetry tells**
2 **us about the changing perceptions of**
3 **volcanoes between the XIX and XXI centuries**

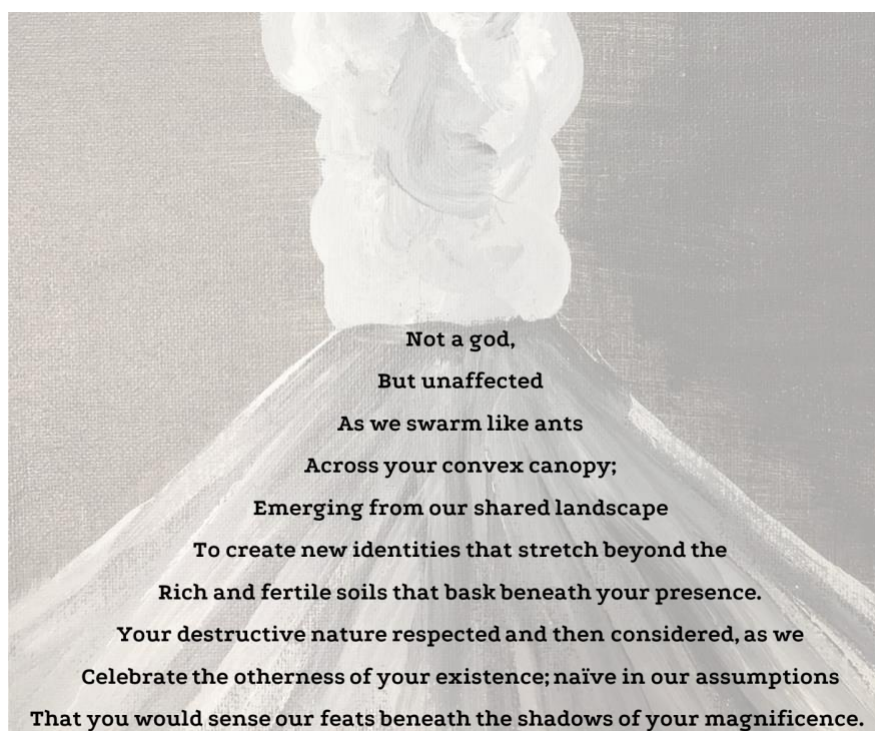

Abstract

In this study we investigate what poetry written about volcanoes from 1800 to the present day reveals about the relationship between volcanoes and the societies and times represented by the poets who wrote about them, including how it evolved over that time frame. In order to address this research question, we conducted a qualitative content analysis of a selection of 34 English-language poems written about the human-volcano interactions. Firstly, we identified the overall connotation of each poem. Then, we recognized specific emerging themes and grouped them in categories. Additionally, we performed a quantitative analysis of the frequency with which each category occurs throughout the decades of the dataset. This analysis reveals that a spiritual element is often present in poetry about volcanoes, transcending both the creative and destructive power that they exert. Furthermore, the human-volcano relationship is especially centred around the sense of identity that volcanoes provide to humans, which may follow from both positive and negative events. These results highlight the suitability of poetry as a means to explore the human perception of geologic phenomena. Additionally, our findings may be relevant to the definition of culturally appropriate communication strategies with communities living nearby active volcanoes.

1. Introduction

We live on a geologically active planet, and volcanoes are one of the most visually impressive geological features of our world. Whereas most geologic phenomena (e.g. orogeny, erosion) occur slowly over a timescale of millions of years, being *de facto* invisible to us humans, volcanic activity is a fast process that can radically change the natural landscape within a matter of hours, directly affecting the nearby communities. There are 150 active volcanoes in the world, and at any given time, about 20 of them are erupting (Durant et al., 2010;Venzke, 2013). The range of volcanic activity is broad (effusive to explosive), and so is the spectrum of feelings they inspire (from awe to fear). Certainly, they do not leave us indifferent (see e.g. Esperanza et al., 2008)

The areal impact footprint of eruptions depends on their Volcano Explosivity Index (VEI). In past times, only large eruptions affecting people (i.e. occurring in inhabited areas) would have been reported and become known worldwide. Large eruptions (VEI>4) statistically occur every few years, and have footprints of tens of kilometres (Brown et al., 2015). Small eruptions (VEI<4) can also significantly affect local population, but before the development of modern means of communication their occurrence would have frequently gone unreported beyond national boundaries. At the beginning of the 19th century there were 10 million people worldwide living within 100 km of volcanoes that have erupted during the Holocene (Siebert et al., 2011); nowadays, that number has increased to 800 million.

Volcanoes constitute a fundamental part of the Earth system, recycling elements from the mantle to the surface and the atmosphere. But cohabiting with them comes with a unique set of challenges and rewards for local communities. Understanding how people perceive volcanoes is fundamental in shaping effective scientific communication strategies, including in times of crises (see e.g. Nave et al., 2016;Donovan et al., 2018;Avvisati et al., 2019). These perceptions may in turn be affected by a variety of factors, including: scientific knowledge, spiritual beliefs, oral history, and personal experience (direct or indirect), which vary widely in space and time across different cultures and historical periods.

Monitoring people's perception of volcanoes is difficult. Psychologists sometimes work with local communities in the aftermath of eruptions (Paton et al., 2000;Sword-Daniels et al., 2018;Paton, 2019), yet these works mainly focus on a very small, specific part of the human-volcano interaction (i.e. the instances in which volcanic activity conflicts with human life), and therefore paint a partial, skewed view of this relationship. Additionally, these interventions have only become common practice in recent times, and therefore cannot shed light on the evolution of the relationship between humans and volcanoes over time

1 A potential medium through which a more nuanced and expansive dataset of this
2 relationship can be established is the arts. The arts might be thought of as ubiquitous
3 expressions of human nature, and have often been inspired by volcanoes, with
4 notable examples including paintings by Turner (Daly, 2011), Warhol (Sigurdsson,
5 2015), and Munch (Olson et al., 2007). We can conceivably use art pieces to guide
6 us in our understanding of how volcano-human relations have changed through time
7 (Hamilton, 2013; Alexander, 2016) For example, previous research has shown how
8 the colours of sunsets painted by famous artists can be used to estimate
9 stratospheric particulate concentrations in the Earth's past atmosphere, revealing
10 that ash and gas released during major volcanic eruptions enhanced sunlight
11 scattering, making sunsets appear redder, as reflected by the paintings that were
12 produced in the aftermaths of such events (Zerefos et al., 2014). Similarly, studies
13 have been conducted which have: dated volcanic eruptions through Neolithic cave
14 paintings (Schmitt et al., 2014), investigated the extent to which artists have used
15 volcanoes to represent societal upheaval and transformation (Sivard, 2011), and
16 even demonstrated how drawing volcanoes can be used to empower children in
17 informal learning environments (Weier, 2004). These examples concern mainly
18 drawings and paintings, aside from which there has been a relative paucity in
19 research that investigates how the arts might be used to shed light on changing
20 perceptions of volcanoes, and how this information can be directly useful in the
21 communication of volcanic hazards and risk in the modern era.

22
23 In this study, we begin to address this gap in the literature by choosing to focus on
24 another form of art: poetry. While attempts to define what is and what is not poetry
25 can be contentious (see e.g. Ribeiro, 2007), here we take poetry to be any written
26 form that is composed by the line. We consider prose to be differentiated from
27 poetry, in that prose is instead composed by sentences and is written with standard
28 grammatical structure. This line-by-line composition of poetry means that it is able to
29 convey meaning in a concise manner, which in turn lends itself to analysis and
30 interpretation. Poetry provides a powerful medium through which to interpret human
31 behaviours and perceptions, and an analysis of poetry as data has been used to
32 provide understanding on topics ranging from living with HIV (Poindexter, 2002) and
33 dementia (Zeilig, 2014), to attitudes relating to environmental change (Illingworth and
34 Jack, 2018) and compassion fatigue in nurses (Jack and Illingworth, 2017). In this
35 study, we aim to build on this research, using poetry as a medium through which to
36 investigate perceptions of human-volcano interactions. Donovan et al. (2011) and
37 Skinner (2011) have also used poetry to gain insight on the human perception of a
38 specific, erupting volcano (Montserrat). Instead, we aim to conduct a wider study.

39
40 By conducting a detailed qualitative content analysis for a selection of volcano
41 poetry, this study aims to understand how poets have interpreted the relationship
42 between humans and volcanoes from the beginning of the nineteenth century to the
43 modern day. In Section 2, we discuss the methodology that was utilised in this study,
44 outlining why this approach was adopted and establishing its validity and reliability.

1 Section 3 contains a discussion of how categories and themes emerged from our
2 analysis, and how this relates to the research question defined in Section 2. Finally,
3 Section 4 contains the conclusions of this study, along with future directions for
4 further research.
5

6 **2. Methodology**

7

8 The methodology that we have adopted in this study involved treating poetry as data,
9 allowing for text to be analysed with respect to attitudes relating to volcanoes. While
10 several other methods exist for the analysis of textual data (e.g. ethnography,
11 phenomenology, grounded theory, etc.), we have chosen qualitative content analysis
12 because of its ability to highlight both the context and the content of the chosen text,
13 which for a subjective medium such as poetry is essential.

14 The methodology that is adopted in this study largely follows that of Illingworth
15 (2019), insofar as the qualitative content analysis of the poetry is guided by these six
16 steps: formulation of research questions; selection of poetry to be analysed;
17 definition of codes and categories to be applied; outline and implementation of
18 coding process; determination of trustworthiness; and analysis of results. The first
19 five of these steps are outlined below, with the analysis of the results presented in
20 Section 3.

21
22 We note here that the poems that were analysed in this study are presented
23 according to the following format: 'Poem Name' by Author Name (Year of
24 Publication), and that links to the full texts of all these poems can be found in Soldati
25 and Illingworth (2019).
26

27 **2.1 Formulation of research question**

28

29 By performing a qualitative content analysis on poetry that has been written about
30 volcanoes, but critically not for the purpose of research, this study aims to better
31 understand the way in which poets, as representatives of society and culture they
32 live in, have interpreted the relationship between humans and volcanoes (both active
33 and not). For the purposes of this study, this has been formulated into the following
34 Research Question (RQ):
35

36 RQ: what does poetry written about volcanoes reveal about the relationship between
37 volcanoes and the societies and times represented by the poets who wrote about
38 them?
39

40 **2.2 Selection of poetry to be analysed**

41

42 We began by selecting poetry that mentioned or featured volcanoes in some
43 capacity. In doing so we set ourselves three constraints. Firstly, the poetry must be

1 written in English, or else have an author-sanctioned English translation; this
2 constraint was because English is the only common language that is shared by the
3 authors of this study. Secondly, the poems must have been written from 1800
4 onwards; this constraint was introduced to make the list more manageable for
5 analysis purposes, and because this was when many consider volcanology to have
6 first been fully established as a scientific discipline through the research of Ben
7 Franklin, James Hutton, Alexander von Humboldt, and others (Sigurdsson, 2000).
8 Finally, where possible, we aimed to find at least one poem per decade, in order to
9 try and better capture any change in attitudes from the early nineteenth century to
10 the present day. Given these constraints, we looked for poetry that mentioned the
11 word 'volcano' or 'volcanoes' and which, in the first instance, came from recognised
12 poets and/or well-established poetry journals, in the following three databases:
13 Poetry Foundation, Poetry Society, and Poetry Archive. Additionally, we reached out
14 to the volcanology research community through the volcanology listserv
15 (volcano@lists.asu.edu) asking for further suggestions. Finally, we performed a
16 manual Google search to fill in decade gaps.

17

18 At this stage, we had a list of 53 poems, spanning every decade from the 1800s to
19 the 2010s. The two authors then independently read these poems and filtered them
20 according to two further criteria: only poems that were 100 lines or less were to be
21 considered, and any poet could only have one of their poems considered for further
22 analysis. The line limit was introduced in order to make the analysis more
23 manageable, and a limit of one poem per poet was introduced to allow for a wider
24 selection of voices to be considered, and also to improve the validity of the approach
25 in terms of the triangulation of data (see Section 2.5). In instances where there were
26 multiple poems from a single poet, we agreed upon the one that we both found to be
27 the most aesthetically pleasing, prior to any formalised content analysis. Poems that
28 were removed because of length included 'The last days of Herculaneum' by Edwin
29 Atherstone (which is over 500 lines long), while poets with more than one poem
30 included Emily Dickinson (six poems, for whom 'I have never seen "Volcanoes"' was
31 chosen) and PB Shelley (two poems, for whom 'The Cloud' was chosen). Following
32 the application of this further selection criteria, 41 poems remained available for
33 analysis. Of those, seven were written by women. The higher representation of male
34 poets is merely due to the higher number of male poets who wrote about volcanoes
35 over the considered time span.

36

37 Both authors then independently read each of the poems and categorised them as
38 being either 'Positive', 'Negative', 'Positive & Negative', 'Neutral', or 'Invalid' in their
39 portrayal of volcanoes from a human perspective (in line with RQ), the results of
40 which can be seen in Table 1.

41

42 Performing this analysis enabled each of the authors to better familiarise themselves
43 with the poetry, and also highlighted any further poems that needed to be removed
44 from the study, because they were 'Invalid', i.e. those poems that did not concern the

1 relationship between volcanoes and humanity. Following this individual analysis (the
2 rows corresponding to 'AS' and 'SI' in Table 1), the two authors met up to exchange
3 their analyses and agree upon a broad classification of the poems in terms of
4 connotation ('Both' in Table 1). This broad categorisation was useful for three
5 reasons. Firstly, it revealed several differences in how the poems had been
6 individually categorised, highlighting how these differences could be discussed and
7 developed, thereby helping to improve the trustworthiness of the subsequent in-
8 depth content analysis by ensuring investigator triangulation (see Section 2.5).
9 Secondly, it revealed that this broad categorisation of the connotations of the poems
10 as either: 'Positive', 'Negative', 'Positive & Negative', or 'Neutral' was too broad to
11 offer any in-depth analysis with respect to the RQ. Finally, this approach revealed
12 additional poems that should be removed from the study because they did not
13 obviously concern the relationship between volcanoes and humanity. For example,
14 'Inside the Ghost Volcano' by Will Alexander (1998) was removed at this stage
15 because the volcano was being used as an abstract metaphor from which no
16 perspective of the perceived relationship between volcanoes and humanity could be
17 directly observed. In total a further 7 poems (the 'Invalid' column in Table 1) were
18 removed following this step, resulting in a total of 34 poems on which to perform a
19 more in-depth content analysis. This further selection criteria meant that two
20 decades were now absent from our study (1940 and 1960). However, given that
21 every other decade from the 1800s onwards was still present we were satisfied that
22 we had a sufficient temporal representation of poems to conduct a detailed content
23 analysis with respect to the RQ.

24

25 **2.3 Definition of codes and categories to be applied**

26

27 A conventional approach to qualitative content analysis was adopted in this study,
28 with preconceived categories being avoided, and categories being determined by the
29 implementation of the coding process instead (see Section 2.4). While in some
30 instances a directed content analysis might be more appropriate, this methodology is
31 usually used in those instances where an existing theory would benefit from further
32 description (Hsieh and Shannon, 2005). As the research question to be addressed in
33 this study is unique, a directed approach is inappropriate. Similarly, a summative
34 content analysis (i.e. one in which the frequency of words and/or phrases was only
35 quantitatively assessed) would fail to fully account for the context of the poetry
36 alongside its content.

37

38 **2.4 Outline and implementation of coding process**

39

40 Both authors individually read each of the 34 poems, and assigned codes to sections
41 of the text (Table 2). As each new code emerged we individually went back through
42 the poems that had previously been coded to check whether these also contained
43 any lines that could be labelled with any newly emergent code. After coding all of the

1 poetry in this manner, we independently read all of the poems in full again and made
2 sure that each of them had been coded accurately and that a saturation of emergent
3 codes had been reached, thereby improving the trustworthiness of the approach
4 (see Section 2.5). As can be seen from Table 2, this resulted in a total of 28 codes (9
5 for SI and 19 for AS). We then read each of the poems again to make sure that no
6 coding had been missed.

7
8 Following this independent coding process, the two individual codebooks (one for AS
9 and one for SI) shown in Table 2 were combined in order to search for emergent
10 categories. This categorisation of the individual codes was initially done by SI, before
11 being modified by AS, and then ratified by both SI and AS, with both authors
12 agreeing upon the five emergent categories (and corresponding codes) shown in
13 Table 3: 'Landscape', 'Identity', 'Destruction', 'Spiritual', and 'Creation', each of which
14 will be discussed in detail in Section 3. After these codes had been grouped as such
15 we went back through each of the individual occurrences (e.g. the 61 segments of
16 poetry that were categorised as 'Landscape') to make sure that they did indeed
17 belong in this category.

18
19 In this combination of codebooks to search for emergent categories, we found that
20 some of our early individual coding had been done erroneously, e.g. in 'Ice Child' by
21 John Haines (1999), the following section was coded as 'Identity' by SI and
22 'Destruction' by AS; however, in the merger of our codebooks we decided that a
23 more appropriate category was actually 'Landscape', which as can be seen from
24 Table 3 was not associated with either of these codes:

25
26 we find your interrupted life,
27 placed here among the trilobites
28 and shells, so late unearthed.

29
30 Following this categorisation, each of the five categories shown in Table 3 were
31 further examined for any theme(s) that expressed underlying meaning in relation to
32 RQ, the results of which are presented in Section 3.7.

33 34 **2.5 Determination of Trustworthiness**

35
36 At each stage of the qualitative content analysis that was adopted in this study, the
37 individual codes and categories were re-examined in order to confirm that they
38 accurately captured the poetry in relation to RQ. Each author carried out this coding
39 independently, until there were no further codes or categories found to be emerging
40 from the data, i.e. until descriptive saturation had been reached (Lambert and
41 Lambert, 2012). Triangulation as a validation strategy (Flick, 2004) was achieved by
42 using data drawn from different times and places (the poems) and conducting an
43 analysis using two different investigators (the authors). This use of systematic
44 sampling, triangulation and constant comparison, and proper audit and

1 documentation (see Section 2.2 and 2.4) combined to ensure both the reliability (i.e.
2 the consistency with which this analysis would produce the same results if repeated)
3 and the validity (i.e. the accuracy or correctness of the findings) of this approach
4 (Leung, 2015). Given that the analysis of the poetry as described here represents a
5 somewhat subjective approach, the reliability of the findings might be called into
6 question. However, as outlined by Morse et al. (2002), our methodological
7 coherence, sampling strategy, and saturation of emergent codes ensures the
8 reliability, and trustworthiness, of our approach in this qualitative analysis.
9

10 **3. Results and Discussion**

11
12 As can be seen from Table 3, five major categories emerged from the thematic
13 coding of the poems used in this study. We will now discuss each of these emergent
14 categories, how they relate to RQ ('what does poetry written about volcanoes reveal
15 about the relationship between volcanoes and the societies and times represented
16 by the poets who wrote about them?'), and how these findings compare to other
17 research that has been conducted into the changing perceptions of volcanoes
18 (Section 3.1 - Section 3.5).
19

20 Following a discussion of these categories we present a quantitative analysis of the
21 poems in terms of how the frequency of these emergent categories have changed
22 over time (Section 3.5), followed by a presentation of the overall theme that emerged
23 from conducting this analysis, and how this relates to RQ (Section 3.6).
24

25 **3.1 Landscape**

26
27 Landscape is the most recurrent of the five emergent categories, being present in
28 every poem that was analysed, regardless of when it was written. Here volcanoes
29 serve primarily as a backdrop; they are part of the environment where the poem is
30 set, typically a prominent feature that dominates the landscape. For example, in
31 'Hunched Back Volcano' by Genevieve Taggard (1914), the poet paints a particularly
32 vivid image of an active volcano, anthropomorphised as having a passionate
33 (erupting) mouth (crater), set against a backdrop of stars:
34

35 Red is the mouth of Pele, passionate
36 Against the fires of the kindling stars:
37 Fire to fire moves: the heavens wait
38

39 By contrast, in 'Mount Broadshield' by Jónas Hallgrímsson (1841) the volcano is now
40 quiet and peaceful - an image highlighted by the presence of snow - though it still
41 dominates the landscape with its (regal) presence:
42

43 Queen of all our country's mountains,

1 crowned with snow sublime and pure!
2 Once you poured from fiery fountains
3 floods of lava down the moor.

4

5 In 'Flowers from the Volcano' by Claribel Alegría (2013), the volcanic crater,
6 presumably at least temporarily inactive, becomes part of the human landscape,
7 representing the place where the flower growers of the poem now live:

8

9 Farther up, in the crater
10 within the crater's walls
11 live peasant families
12 who cultivate flowers
13 their children can sell.

14

15 Even in its absence, the volcano can still dominate the landscape. For example, in
16 'Road Trip' by Vijay Seshadri (2016), it is not the volcano itself which provides the
17 poem's setting, but rather the beaches that came from its erosion, with their black
18 sand and tide pools excavated in its obsidian lava:

19

20 Tomorrow or the day after or the day after that,
21 on the volcano beaches fringed with black sand
22 and heaped with tangled beds of kelp,
23 by the obsidian tide pools that cradle the ribbed limpet
24 and the rockbound star,

25

26 These poems also capture the effect that volcanoes have in changing the landscape,
27 such as in 'Peace' by D H Lawrence (1929), which provides a description of an
28 effusive eruption; firstly, as it occurs:

29

30 Brilliant, intolerable lava
31 Brilliant as a powerful burning-glass
32 Walking like a royal snake down the mountain to-
33 wards the sea.

34

35 And then, after the eruption has ceased:

36

37 Peace congealed in black lava on the doorstep.
38 Within, white-hot lava, never at peace
39 Till it burst forth blinding, withering the earth;
40 To set again into rock
41 Grey-black rock.

42

43 These descriptions of the changing landscape also highlight how the language that is
44 used by poets in their descriptions can both reinforce and counteract scientific

1 terminology and understanding. The likening of lava to glass is scientifically
2 accurate, as both lava and glass are examples of a silicate melt. In contrast to this,
3 the use of colour in this passage, whilst evocative, is not actually grounded in reality:
4 lava does indeed turn into black or grey-black rock as it cools down, but is never
5 white-hot. The colour choice may have been dictated by a contrast (black vs. white)
6 or by the idea, pushed further than it actually occurs in reality, that the hotter
7 something gets the closer it gets to white (with lava typically stopping at red-orange),
8 and the idea of hot, molten lava still persisting within a cooled, solid outer crust does
9 in fact accurately reflect the inward cooling process of lava flows. This is of course
10 not to say that poems should ensure scientific accuracy at the cost of their
11 aesthetics; we draw attention to these scientific inaccuracies only to highlight that we
12 are not interested in how accurately these poems capture volcanic behaviour, but
13 rather what the poetry can tell us about the relationship between humanity and
14 volcanoes. This use of poetry, mirrors that which Aristotle observed in the *Poetics*,
15 i.e. that whilst history deals with specific events, poetry deals with general truths
16 (Yanal, 1982).

17

18 The fact that volcanoes feature so prominently as a setting in these poems highlights
19 that the poets perceived very clearly how humanity relates to volcanoes. Similarly,
20 the language used in the poetry acts to position volcanoes as an awesome part of
21 our shared landscape, perhaps explaining in part why humans were first drawn to
22 them before they became valued for more tangible goods such as precious metals
23 and stones (Fisher et al., 1998), as well as soil fertility.

24

25 **3.2 Identity**

26

27 Volcanoes are often used to represent or highlight part of the poet's identity. They
28 are present in their childhood memories, as well as in family history or cultural
29 heritage. Identity is the second most recurrent category (after 'Landscape'), missing
30 from only two of the analysed decades: the 1860s and 1880s. This ubiquity is
31 extremely revealing of the profound tie between humans and volcanoes; here the
32 volcanoes are not merely passive elements of the landscape, but rather active
33 agents. Even when they are standing still, their presence is so impactful as to be
34 defining for the poet, as evidenced in 'Punctuation Marks' by Phillip Nanton (1992),
35 set on the author's native island of Saint Vincent (Saint Vincent and the Grenadines),
36 whose landscape is metaphorically dominated by the active volcano La Soufrière:

37

38 Come nearer, focus on one dot of an island
39 I was born there, on the rim of a volcano
40 on the edge of a large full stop
41 where the sand is black
42 where the hills turn a gun-barrel blue
43 where the sea perpetually dashes at the shoreline
44 trying to reclaim it all.

Similarly, in 'Flowers from the Volcano' by Claribel Alegría (2013), the poet's home country of El Salvador is remembered nostalgically, its personal resonance defined by the situation of its volcanoes:

Fourteen volcanos rise
in my remembered country
in my mythical country.

In this poem, the volcanoes represent not only the literal volcanoes in that region, but also the eruption of violence brought about by the civil wars of the 1970s and 1980s across El Salvador, Nicaragua, and Guatemala, and how they too came to form a part of the poet's life and identity.

This personalisation of the volcano is continued in 'Sonnet 5' by Pablo Neruda (1959), for whom volcanoes become the distinctive feature of his native Chile, elevated to the same rank as the love / lover which the poet found there:

and on through the streets like a man wounded,
until I understood, Love: I had found
my place, a land of kisses and volcanoes.

In many of these instances of identity, the volcano takes centre stage in a formative childhood memory, such as in 'What For' by Garrett Hongo (1982), where the poet expresses the extent to which his childhood identity was itself defined by the presence of volcanoes:

I lived for the red volcano dirt
staining my toes, the salt residue
of surf and sea wind in my hair,
the arc of a flat stone skipping
in the hollow trough of a wave.

In contrast to this, 'Axis' by Ray Gonzalez (2015) captures the way in which a particular volcano is a matter of family history, a mythical entity that the poet himself did not experience personally, but which is nonetheless present in the defining stories of his heritage:

The volcano in my grandmother's Mexican village
smothered the town, though the girl escaped because
the axis of revolution sent her family into exile,

Here this identity is not necessarily a positive one: the forced exile of the poet's grandmother is remembered as an environmental revolution which they were

1 powerless to avoid, but which became a defining aspect of both the grandmother
2 and her grandson's assumed identity.

3
4 Identity is a nuanced concept, and has both positive and negative connotations
5 associated with it. However, what is evident from these poems is that these
6 associations are typically not purely adverse, and even when they are they form
7 important societal ties that have come to define both past and current generations.
8 Although the destructive impacts of volcanoes are well documented and recognized,
9 many of the possible societal and cultural benefits are not always fully considered
10 (Kelman and Mather, 2008), and the emergence of identity as a key category across
11 the majority of the analysed poems serves to further highlight this disparity.

12 13 **3.3 Destruction**

14
15 This category considers those poems that make reference in some part to the
16 destructive power of volcanoes, in relation to humankind. Poems that were
17 categorised as such include those that make reference to physical damage of
18 societal assets or destruction to human beings, such as is evident from this extract
19 from 'Blankets of Blood' by Arthur Rimbaud (1872):

20
21 Oh my friends! —My heart knows its own brothers!
22 Dark strangers, what if we were to leave? So leave! Leave!
23 O misfortune! How the earth melts upon us,
24 How I shake as it melts on me and you,
25

26 These poems also consider those that make reference to physical damage or
27 destruction to property or land that is owned and/or cherished by humans, such as in
28 this passage from 'Peace' by DH Lawrence (1929):

29
30 Forests, cities, bridges
31 Gone again in the bright trail of lava.
32 Naxos thousands of feet below the olive-roots,
33 And now the olive leaves thousands of feet below the
34 lava fire.
35

36 This category also includes those poems that highlight the mental anguish of people
37 caused by the negative effects of volcanoes, either directly through their eruptions or
38 indirectly through the oppressive nature of living within close proximity to them, as
39 can be seen in this extract from 'Negotiations with a Volcano' by Naomi Shihab Nye
40 (1995):

41
42 We need dreams the shape of lakes,
43 with mornings in them thick as fish.
44 Shade us while we cast and hook—

1 but nothing else, nothing else.

2
3 The permeating sense of fear that is evident from this extract acts as a powerful
4 testament to the severe mental anguish that experiencing a volcanic eruption and/or
5 living near an active volcano can have on local residents, capturing these negative
6 mental health effects in a manner that does not diminish them in comparison to more
7 tangible examples of volcanic destruction. Research into the mental health impacts
8 following volcanic eruptions have shown that nearby residents are at an increased
9 risk of experiencing symptoms of post-traumatic stress disorder (Gissurardóttir et al.,
10 2019) and mental stress due to the loss (or threat of loss) of property (Horwell et al.,
11 2015). Indeed, such research has also highlighted the importance of implementing
12 psychosocial interventions with volunteers, both during and after a volcanic eruption,
13 in order to alleviate severe mental health risks (Espinoza et al., 2019). By
14 highlighting the mental distress that volcanoes can cause to humans, these poems
15 serve to highlight why this should not be neglected when considering the potential
16 impacts of volcanic activity.

17
18 Finally, this category also considers those poems in which volcanoes are responsible
19 for the fatality of human beings, as can be seen in these lines from 'Flowers from the
20 Volcano' by Claribel Alegría (2013):

21
22 Eternal Chacmol collects blood,
23 the gray orphans
24 the volcano spitting bright lava
25 and the dead guerrillero
26 and the thousand betrayed faces,
27 the children who are watching
28 so they can tell of it.

29
30 Here 'Chacmol' likely refers to a distinctive form of Mesoamerican sculpture
31 associated with sacrifice, and in this poem, the poet asks us to reflect on the role of
32 the volcanoes in shaping the landscape of Central America. Through death, several
33 of these poems invite us to consider how such sacrifices can result in new creation
34 (see Section 3.5), but they also serve as a reminder to the reader of the vast power
35 that these volcanoes possess, encouraging us humans to both respect and, at times,
36 fear their presence.

37
38 Given the severe destruction that volcanoes can wrought, as highlighted by this
39 emergent category, these poems might suggest that communities would not choose
40 to live in such environments of their own volition. However, when such destructive
41 incidents occur in the poetry, they rarely appear in isolation, and instead tend to
42 appear alongside other categories which represent potential benefits, not least
43 'Identity' (Section 3.2) and 'Creation' (Section 3.5). This contrast of categories
44 implies that in many instances the poets were intending to capture a mutuality of

1 both potential hazards and benefits. This interpretation further supports the findings
2 of other studies which have highlighted that many communities choose to expose
3 themselves to the negative consequences of volcanic hazards, so that they might
4 enjoy the benefits and opportunities that arise within the human–volcano system
5 (see e.g. Bachri et al., 2015;Stoffle et al., 2015).

6 7 **3.4 Spiritual**

8
9 As can be seen from Table 2 and Table 3, this category emerged from a single code,
10 which both authors independently labelled as such. This category represents those
11 poems that were considered to make reference to aspects of volcanoes that were of
12 spiritual significance. Some of the poems that were coded in this category make a
13 specific mention of religious figures, such as these references to Christ in ‘Etna’ by
14 Emily Pfeiffer (1889):

15
16 Martyr of mountains, shall I say, the Christ,
17 Bearing earth's sorrows, for its trespass made
18 Sin, that her sons may reap the fair increase
19 Of smiling fields? The offering hath sufficed:

20
21 And also, those in ‘St Telemachus’ by Alfred Tennyson (1892):

22
23 In the great name of Him who died for men,
24 Christ Jesus!’ For one moment afterward
25 A silence follow’d as of death, and then
26 A hiss as from a wilderness of snakes,
27 Then one deep roar as of a breaking sea,
28 And then a shower of stones that stoned him dead,
29 And then once more a silence as of death.

30
31 Given the selection of English-language poems for this study, there is a strong
32 weighting towards poems that make reference to biblical figures from Christianity,
33 although other religious figures, such as the Buddha and several Mesoamerican
34 deities also feature, especially in those poems which were originally written in
35 another language, and yet for which an author-sanctioned translation exists (see
36 Section 2.2). For example, in ‘A tale for Puuooo’ by Taeko Jane Takahashi (2002),
37 we hear how:

38
39 Pele the goddess pierced and
40 thrust, spilling lava into
41 Royal Gardens subdivision.
42

1 Here, Pele is the goddess of volcanoes and fire in the Hawaiian religion, where she
2 is also considered to be the creator of the Hawaiian Islands. In some instances, the
3 volcano itself is considered to be the chief religious figure or deity, such as in these
4 lines from 'Ice Child' by John Haines (1999), in which the volcano is explicitly
5 referred to as a now dormant god:

6
7 Under the weight of this mountain—
8 once a god, now only restless stone,
9 we find your interrupted life,
10 placed here among the trilobites
11 and shells, so late unearthed.

12
13 Or in 'Burning Island' by Gary Snider (1970), in which the volcano is given the status
14 of a spiritual creator and protector:

15
16 Volcano belly Keeper who lifted this island
17 for our own beaded bodies adornment
18 and sprinkles us all with his laugh—
19

20 At times this spirituality manifests itself with the poet (or their protagonist) appealing
21 to the volcano for either forgiveness or clemency, such as in 'Negotiations with a
22 Volcano' by Naomi Shihab Nye (1995), where the author pleads for mercy with the
23 volcano as they might do with another deity or spiritual figure:

24
25 Forgive any anger we feel toward the earth,
26 when the rains do not come, or they come too much,
27 and swallow our corn.
28 It is not easy to be this small and live in your shadow.
29

30 These lines also demonstrate how this associated spirituality serves to create an
31 'otherness', i.e. that volcanoes and humans might occupy the same landscape but
32 they are vastly different entities in terms of both temporal and spatial scales. The
33 separation that is imposed by this emergent spirituality also highlights potential
34 difficulties for cohabiting. There is at times a perceived unidirectional flow of power
35 that makes establishing a truly symbiotic relationship seem improbable, as can be
36 seen in the following lines from 'Ice Child':

37
38 Was it God—the sun-god of the Incas,
39 the imperial god of the Spaniards?
40 Or only the priests of that god,
41 self-elected—voice of the volcano
42 that speaks once in a hundred years.
43

1 The interpretations of volcanic eruptions have been shown to be interconnected with
2 the understanding of tradition by different religions and religious figures (see e.g.
3 Gaillard and Texier, 2010). The poems that feature in this category further
4 demonstrate that there is clearly a spiritual connection between volcanoes and
5 humans, whilst also serving to highlight the spiritual reverence in which volcanoes
6 are held, and the distance that this can introduce. By considering the spirituality of
7 volcanoes, these poems also ask us to contemplate the persistence of the spiritual
8 life system within a particular territory, aligning with previous research which has
9 shown how when humans push these boundaries in order to exploit them, the
10 system can become disrupted (Vitale, 2017).

11
12

13 **3.5 Creation**

14

15 The final category to emerge from this analysis is one of 'Creation'. Poems that
16 feature in this category demonstrate how volcanoes can act as a creative (as
17 opposed to, or in addition to being a destructive) force. For example, 'Darkness' by
18 George Byron (1816) unknowingly explores the aftermath and potential
19 consequences of the 1815 eruption of Mt Tambora, Sumbawa, Indonesia, an event
20 whose subsequent volcanic winter resulted in the infamous 'year without a summer'
21 (Stommel and Stommel, 1979), as it would have been later discovered. Yet, despite
22 the overall negative connotations of this poem, Byron still recognizes that prior to this
23 eruption living alongside volcanoes was a positive experience, a source of happiness
24 even:

25

26 Happy were those who dwelt within the eye
27 Of the volcanos, and their mountain-torch:

28

29 Another poem that demonstrates the creative potential of the volcano is 'Burning
30 Island' by Gary Snider (1970), in which the poet asks us to consider the fertile soils
31 that volcanoes provide, enabling a peaceful and profitable co-habitation:

32

33 As we hoe the field
34 let sweet potato grow.
35 And as sit us all down when we may
36 To consider the Dharma
37 bring with a flower and a glimmer.
38 Let us all sleep in peace together.

39

40 Many residents who live near volcanoes view eruptions as agents of change, often
41 change for the good (Dove, 2008), which can in turn influence the extent to which
42 they perceive the hazard and risk of living of living near to volcanoes. 'Burning
43 Island' highlights the potential benefits of living in volcanic regions, where the rich
44 volcanic soils can support highly productive agriculture (Rampengan et al., 2016).

1 However, it also draws attention to the fact that the benefits of this relationship would
2 appear to be unidirectional – volcanoes do not benefit from cohabiting the landscape
3 with humans.

4
5 Continuing with notions of cohabiting, this category features those poems that
6 demonstrate how such a relationship can be peaceful. For example, in ‘Peace’ by
7 DH Lawrence (1929) the concept of placatory cohabitation is explored in the very
8 first lines:

9
10 PEACE is written on the doorstep
11 In lava.

12
13 Here the potentially destructive lava gets all the way to the house, yet stops on the
14 doorstep, respectful of the human space. However, even here the potential dangers
15 of this cohabitation are clearly apparent: is this message from the volcano a genuine
16 offering of peace, or a warning shot across the bow; a reminder to humans of their
17 position in the hierarchical relationship that emerges through a consideration of the
18 ‘Spiritual’ (Section 2.4)? ‘Negotiations with a Volcano’ by Naomi Shihab Nye (1995)
19 further explores the fragile nature of this cohabitation, explicitly wishing for the
20 volcano to remain dormant, and offering to be peaceful themselves if this wish is
21 granted:

22
23 We would be happy if you slept forever.
24 We will tend the slopes we plant, singing the songs
25 our grandfathers taught us before we inherited their fear.
26 We will try not to argue among ourselves.

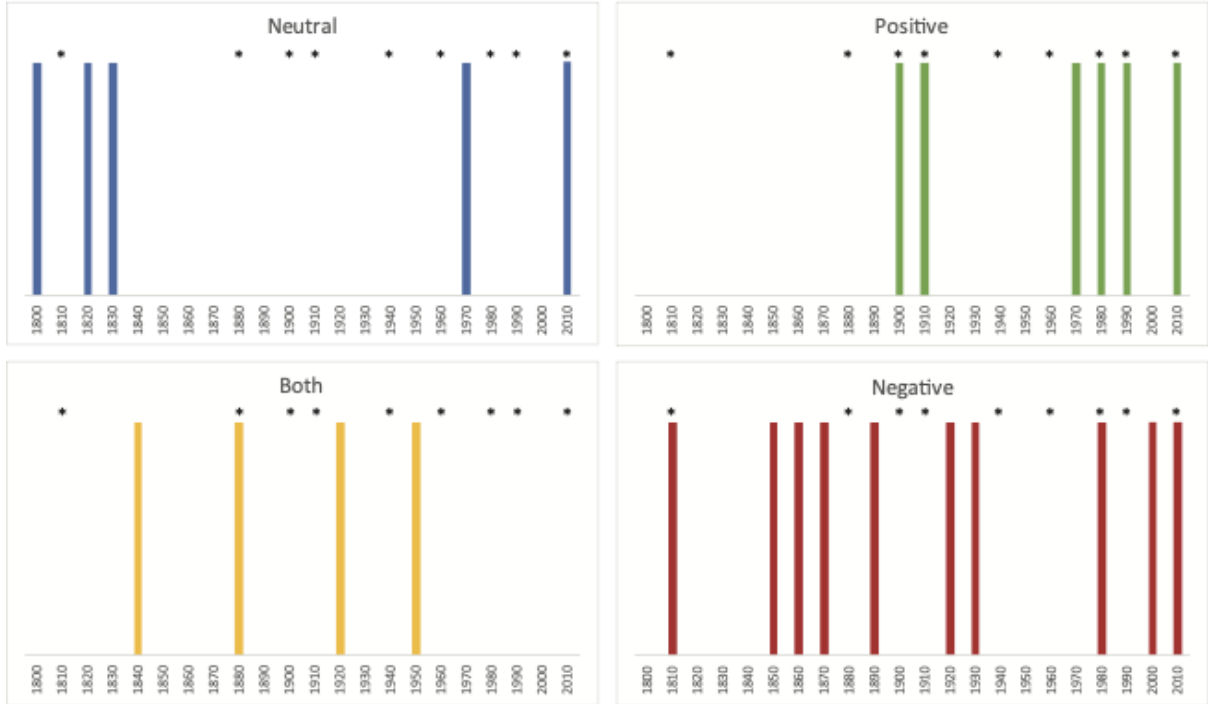
27
28 In considering the potential for a creative and peaceful cohabitation of the landscape,
29 this category demonstrates how such a relationship is conditional, and is reliant on
30 the volcanoes to ‘behave’ in a certain manner towards (or with respect to) humanity.

31 32 **3.6 Quantitative Analysis**

33
34 After performing this qualitative content analysis, we quantitatively analysed how
35 both the connotation of volcanoes (‘Neutral’, ‘Positive’, ‘Negative’, ‘Both’) as well as
36 the frequency of the five emergent categories evolved through time in our dataset.
37 Due to the limited sample size (n=34), this quantitative analysis cannot be
38 considered statistically significant. In order to do so, we aggregated our dataset by
39 decade, and normalized the identified connotations and categories to the number of
40 poems in which they were represented (Table 4). Furthermore, we considered the
41 major eruptions which occurred in the Northern Hemisphere (where the majority of
42 the poets used in this study lived) across the considered time frame (Table 5), and
43 correlated these with the connotations and categories of the dataset. The purpose of
44 this quantitative analysis was not to apply a statistical interpretation of the volcano-

1 human interactions of the analysed poetry; rather it was read alongside the
 2 qualitative analysis in support of the emergent theme (Section 3.6) that arose from a
 3 consideration of these poems.

4
 5 As can be seen from Fig. 1, poems in which volcanoes have either a 'Neutral' or
 6 'Both' a positive and negative connotation, and therefore do not express a partial
 7 value judgement, can be found consistently throughout the time span considered
 8 (i.e. from the 1800s to the 2010s). The same can be also said for poems where
 9 volcanoes are depicted with an overall 'Negative' connotation. In contrast, a
 10 'Positive' representation of volcanoes only emerges in the 1900s, and does not
 11 become frequent until the 1970s.



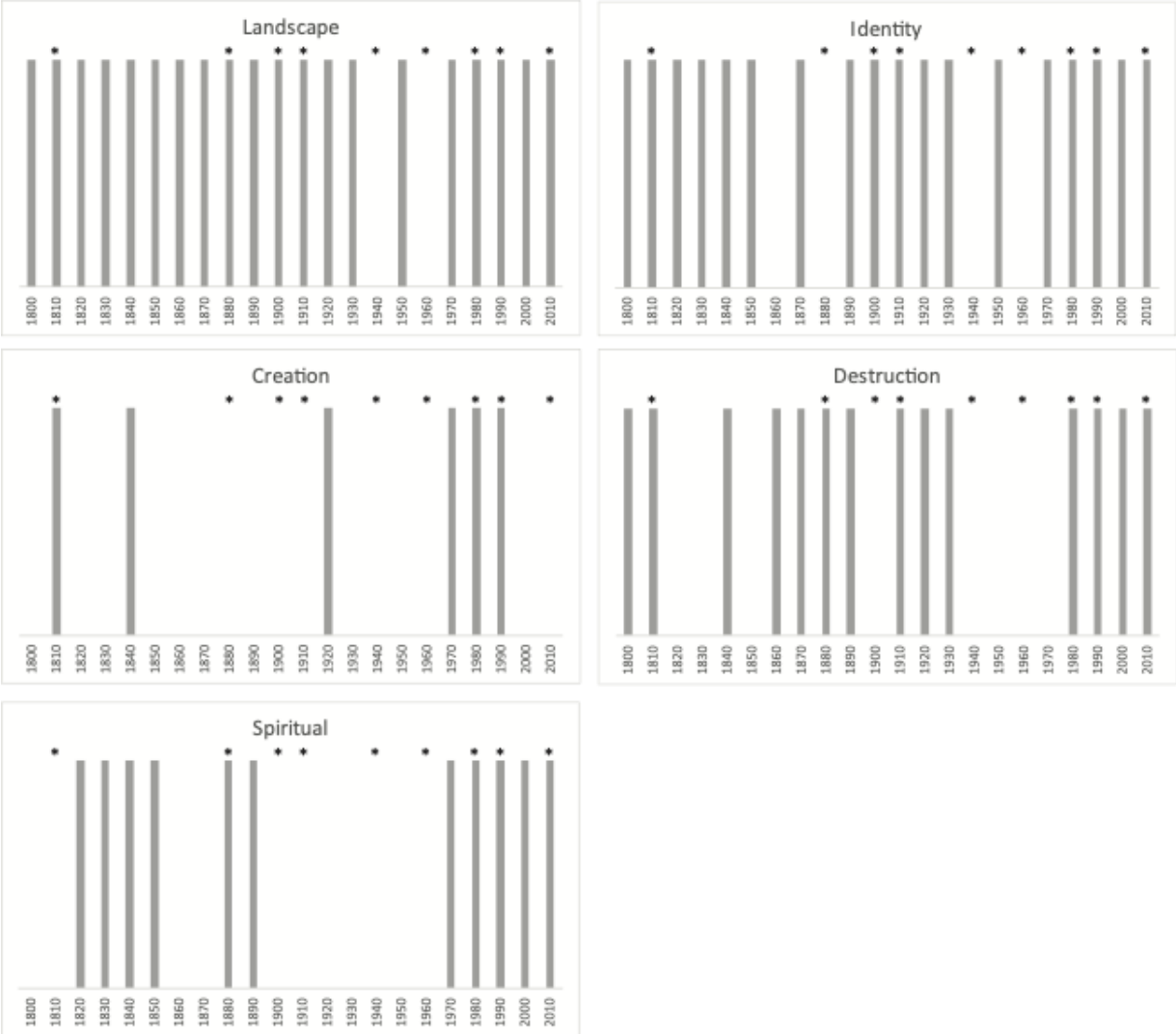

16
 17 Plotting major eruptions alongside the associated connotations of the selected
 18 poems (Fig. 1) does not reveal any obvious correlation. This can be attributed to the
 19 fact that the vast majority of the analysed poems do not focus on specific volcanic
 20 eruptions, but rather that they consider human-volcano interactions more generally.
 21 One notable exception is the poem 'Darkness' by George Byron (1816), which as
 22 discussed in Section 3.5 is grounded in the eruption of Mount Tambora in 1815, and
 23 the subsequent 'year without summer'. During this eruption, volcanic ash was
 24 injected high into the stratosphere, where it circled the globe and persisted for a
 25 considerable time, visibly filtered the sunlight, and causing a negative thermal
 26 anomaly of at least half a degree Celsius in the Northern Hemisphere, as well as a
 27 famine that ultimately killed over 70,000 people (Brohan et al., 2016). This event

1 inspired artists in all fields (e.g. Turner’s famous sunset paintings, and Mary
 2 Shelley’s *Frankenstein*), with Byron’s poem also bearing witness to this event:

3
 4 I had a dream, which was not all a dream.
 5 The bright sun was extinguish'd, and the stars
 6 Did wander darkling in the eternal space,
 7 Rayless, and pathless, and the icy earth
 8 Swung blind and blackening in the moonless air;
 9 Morn came and went—and came, and brought no day,

11

 15 At the categories scale (Fig. 2), we see that the volcano-human interactions in
 16 relation to the ‘Landscape’ occur in all represented decades (as discussed in Section
 17 2.2 the 1940s and 1960s are not represented in this analysis). The notions of
 18 ‘Identity’ that are associated with these interactions are almost as ubiquitous, with
 19 the only exceptions being the 1860s and 1880s.

1
2 As can be seen from Fig. 2, the 'Destruction' in the volcano-human interactions of
3 the selected poetry is represented more frequently across the considered time period
4 than the 'Creation' of such interactions. There is also somewhat of a correlation
5 between 'Destruction' and each of the major volcanic eruptions that happened in this
6 period, with the 1900s being the only decade which featured a major volcanic
7 eruption in the Northern Hemisphere (Table 5) and which did not feature a poem that
8 considered the destructive nature of volcano-human interactions (again noting that
9 the 1940s and 1960s are not represented in this analysis). This would indicate that
10 even if poets were not writing about specific volcanic events, their attitudes might
11 have been affected by them (and the social and economic impacts that these large
12 volcanic events resulted in), leading to poems that more readily considered the
13 'Destructive' rather than 'Creative' nature of such interactions.
14

15 The 'Spiritual' category occurs across the considered time period, with a notable gap
16 in the first half of the twentieth century. This might in part be explained by the
17 tensions between poetry and religion that had manifested themselves throughout the
18 Victorian age (because of the constraints in the selection of the poetry discussed in
19 Section 2.2, the majority of the poems from this era came from either British or
20 American writers), with religion becoming increasingly personal and secular as
21 society became more democratic (Fraser, 1986). Similarly, the re-appearance of this
22 category in later poems corresponds to the emergence of a new Romantic
23 movement that began in the 1960s, in which people (and poets) began identifying
24 themselves as 'spiritual but not religious' (Thomas, 2006), which could explain the
25 re-emergence of 'Spirituality' in the poetry of this period.
26
27

28 **3.7 An emergent theme**

29

30 In considering the five categories identified in this analysis of the poetry, a clear
31 theme emerges with respect to the RQ (what does poetry written about volcanoes
32 reveal about the relationship between volcanoes and the societies and times
33 represented by the poets who wrote about them?): that there is a strong sense of
34 identity associated between humans and volcanoes.
35

36 An analysis of these poems has revealed that humans and volcanoes occupy the
37 same 'Landscape', and that whilst there is a certain reverence associated with their
38 'Destruction', there are also many positives associated with living alongside them.
39 Surprisingly however, these positives are mainly linked to notions of 'Identity' (e.g.
40 family histories and cultural heritages) rather than the physical benefits of 'Creation'
41 (e.g. fertile soils). These poems also highlight that this is a unidirectional relationship,
42 in part because of the distancing brought about by the associated 'Spirituality' or
43 otherness of the volcanoes, with humans ultimately of neither benefit nor concern to
44 the volcanoes that they write about. A different selection of poems, including work

1 from indigenous communities who grant volcanoes a higher cultural stand (e.g.
2 personification or divinisation), might yield a different perspective.

3
4 This emergent theme is further supported by the quantitative analysis discussed in
5 Section 3.6, where over the time period considered there is a relative ubiquity of the
6 'Identity' to emerge from the poems. Similarly, despite the major cultural and societal
7 changes that have occurred over this time period, attitudes towards the human-
8 volcano interaction have not noticeably shifted in favour of one category or another;
9 the volcanoes have remained an ever present, suggesting that they are impervious
10 to these changes and further highlighting their unidirectional relationship with
11 humanity.

13 **4. Conclusions**

14
15 The purpose of this study was to investigate what poetry written about volcanoes
16 reveals about the relationship between humanity and volcanoes. By conducting a
17 qualitative content analysis of a selection of poems written from the 1800s to the
18 present day, a series of themes emerged that characterised this relationship. The
19 volcanoes as 'Landscape' and 'Identity' were seen as dominant, with consideration
20 also given to the 'Destruction' and 'Spirituality' associated with these human-volcano
21 interactions, and to a lesser extent their potential for 'Creation'. The main theme to
22 emerge, both from these categories and the poems themselves, is that there is a
23 strong sense of identity associated with volcanoes by humans (e.g. in terms of family
24 histories, cultural heritage etc.), and that it is the humans (and not the volcanoes)
25 that are affected by this relationship. A quantitative analysis of the frequency with
26 which these categories occurred throughout the decades of this dataset supported
27 the findings of this qualitative analysis, thereby further improving the validity and
28 reliability of the main finding of this study, i.e. that the relationship between humanity
29 and volcanoes is unidirectional and focused on identity.

30
31 The outcomes of this study support other research findings which have
32 demonstrated that many communities are willing to accept the associated risks of
33 living near volcanoes, including active ones, in order to experience the cultural and
34 societal benefits (i.e. 'Identity') that they afford (see e.g. Schmincke, 2004; Kelman
35 and Mather, 2008). Furthermore, by asking us to consider the emergent
36 unidirectional nature of this relationship, this study also challenges us to re-consider
37 the importance of humanity in our interactions with volcanoes. Unlike many other
38 elements of our natural environment that have a strong sense of cultural and social
39 identity attached to them – for example, glaciers (Gagné et al., 2014), rivers
40 (Macklin, 1999), and rainforests (Roosevelt, 2013) – volcanoes are unlikely to be
41 affected by e.g. anthropogenic climate change. Indeed, aside from humans,
42 volcanism is itself a key driver in short-term climatic variations.

1 The main limitation for this study is that only English-language poems were
2 considered. This means that there is likely a bias towards certain attitudes or
3 behaviours, especially those that were found to emerge from the 'Spirituality'
4 category. Future research could, and should, include poetry written in multiple
5 languages to account for this limitation, as doing so would reveal a broader
6 understanding of how poets interpret human-volcano interactions, especially for
7 communities from the Southern Hemisphere. Additionally, the majority of poems
8 considered were authored by male poets, due to the scarcity of poems about
9 volcanoes written by female poets, especially for the 19th Century. It is also worth
10 noting that throughout the 220 years considered in this study, the cultural, social, and
11 political backdrop of the poems has changed significantly. For example, colonialism
12 has the potential of having significantly affected the representation of cultural
13 elements in poetry. Whereas a detailed analysis of how these changes affected the
14 content and tone of the poems is beyond the scope of this work, future studies
15 focussing on this aspect would certainly be valuable. Finally, the limited size of the
16 analysed dataset, i.e. 34 poems, advises caution when extrapolating the findings of
17 this study to the poets' fellow human beings.

18

19 In addition to future studies considering a wider variety of languages and cultures,
20 such work might also consider how different attitudes towards human-volcano
21 interactions are captured by those poets who have physically encountered a volcano
22 versus those who are relying on second-hand testimony. Furthermore, by outlining
23 how poems can be used as a form of data to provide further insight into how human-
24 volcano interactions are perceived, this study suggests that a similar approach might
25 also be adopted for other geoscientific events or phenomena.

26

27 This study has demonstrated that poetry is a powerful medium through which to
28 consider perceptions of our natural environment. Our methodology could become an
29 integral part of a deeper analysis to develop communication strategies with
30 communities living nearby active volcanoes. For example, it could provide more
31 appropriate (i.e. locally sourced) language to engage the communities in
32 conversation. It is in fact critical that local cultural and religious beliefs be taken into
33 account when communicating volcanic hazard, as demonstrated by several social
34 volcanology studies (Cashman and Cronin, 2008;Donovan, 2010;Lavigne et al.,
35 2008;Paton et al., 2008). We welcome interested readers to get in contact with us for
36 participation in the next stage of this research, in which we hope to broaden our
37 analysis beyond the constraints of the English language.
